



## What is Redbone?

In 1984 Gary and Susan Ellis' newborn daughter, Nicole, was diagnosed with cystic fibrosis, a genetic disease that causes the body to produce an abnormally thick, sticky mucus that clogs the lungs and can lead to life-threatening lung infections. They were told that with considerable care, she should live to her early teens. After asking the question, "What is cystic fibrosis?" they set out to find a way to fight it.

In 1988 with the help of their friends, including baseball legend Ted Williams, they founded the Redbone Celebrity Tournament Series to help fund CF research. Guides, anglers and celebrities from film and sports teamed up on thirty-three boats to fish for redfish and bonefish. From that tournament came the name "Redbone." They raised \$16,000 that first year and more importantly, introduced cystic fibrosis into the conscience of the very caring community of the Florida Keys.

From that small seed, the Redbone Series has grown to include the Redbone Trilogy, thirteen Redbone@Large tournaments throughout the United States, Costa Rica and Mexico, four Redbone Red•Trout Tournaments, and one Redbone Bahamas Bonefish Classic. In the last ten years, Tournaments bearing the Redbone name have averaged over a million dollars a year to fight cystic fibrosis.

## TOURNAMENT RULES

1. All participants must "sign-off" on Tournament Rules and Score sheets.
2. Both sailfish and rooster fish should be photographed, and released to constitute a catch. Fish must be entered on score sheet at time of release to avoid disqualification.
3. IGFA rules and tackle specifications apply in all categories; fly, spin, and conventional. Only the angler can touch the rod. ONLY the angler can cast, hook, and fight the fish
4. No heavier than thirty (30) pound test line (Manufacturer's Stated Test) for General Division and twenty (20) pound test line for Fly and Artificial Division. One working rod per angler.
5. Fly and Spin/Plug Divisions are artificial lure categories. No tipping is permitted. Bait or tipping is permitted only in the General Division. In all divisions.
6. There must be two (2) Anglers on every participating boat (4 anglers on strike boats). In the absence of a teammate or celebrity Angler, a substitute Angler will be appointed by the Tournament Committee. The Redbone tournaments are TEAM events. In the spirit of good sportsmanship, we encourage equal casting opportunities to both teammates.
7. Boats must depart from and return to Tournament Fishing Headquarters by water. At the "Blessing of the Fleet" on Day 1, boats must depart in the order they are announced.
8. Fishing hours will be announced at the Tournament Rules Meetings.
9. Ties will be awarded to the Angler who catches the last fish first.
10. The Rules Committee will make any weather decisions. All decisions of the Rules Committee are final.
11. The penalty for any violation of the rules is NO POINTS for the day. All protests must be in writing and signed. They must be presented to the Rules Committee within one hour of LINES OUT on the day of the violation.
12. The Grand Champion Angler Award will be presented to the angler with the most qualified catches. The Team Grand Champion Award will be presented to both anglers on the team that has accumulated the most combined points.
13. Release Points will be awarded as follows:

**Daily Schedule:** Boats are ready at the dock starting at 6:30am and Eco tours at our front door at 7:00am. The Spa is open starting at 10:00am, by appointment only. Lunch will be provided onboard for the anglers and those on full-day Eco tours. Lunch is provided in the dining room for guests on 1/2 day tours or just relaxing at the resort. The fishing day ends by 3:30pm each afternoon. There is time before dinner to enjoy happy hour and hors d'oeuvres in the air-conditioned bar, cool off in the pool, take a sunset kayak tour, or grab a massage in the spa. Half-day Eco tours are scheduled from 7am to 12 noon or 1pm to 4 or 4:30pm. There is some flexibility on start times.

**Meals:** Breakfast is served between 5:30am to 8:30am, Lunch 12 noon to 1:30pm and Dinner from 6:00pm to 8:30pm. Hors d'oeuvre and Happy Hour are served before dinner starting at 4:30pm. They accommodate dietary requests but advanced notice is recommended. Their gourmet meals are restaurant or buffet style with a full menu and variety of entrees including choice of fresh fish, chicken, and beef dishes. Bottled water is in each room and ice is available at the resort kitchen.
